GENERAL RULES

24. Service Classification Riders (Available on Request) - Continued

RIDER R - Net Metering for Customer-Generators - Continued

A. Applicability - Continued

Service will be provided under this Rider to Customers with eligible electric generating equipment (as described above), subject to the provisions of this Rider, including the term of service specified in Section I, as follows:

- non-wind electric generating equipment located on the premises of demand-billed Customers who do
 not participate in CDG or on the premises of demand-billed or energy-only RNM Host Accounts;
 provided that the project either is in service or completed Step 4 of the SIR for generation rated 50 kW
 or less or Step 8 of the SIR for generation rated above 50 kW no later than July 17, 2017;
- 2. non-wind electric generating equipment located on the premises of CDG Host Accounts, provided that: (a) the project was either in service or completed Step 4 of the SIR for generation rated 50 kW or less or Step 8 of the SIR for generation rated above 50 kW no later than July 17, 2017, and (b) the total rated generating capacity of CDG Host Accounts served under this Rider does not exceed 137,000 kW;
- 3. non-wind electric generating equipment located on the premises of Customers billed under energy-only rates, provided that: (a) the generating equipment supplies energy to a single account behind the same meter as the generating equipment; and (b) the project is in service no later than January 1, 2020 (unless the PSC issues an Order directing an earlier end-date); and
- 4. wind electric generating equipment, provided that the total rated generating capacity of wind electric generating equipment served under this Rider does not exceed 33,246 kW.

The Company will process requests for interconnection under this Rider in accordance with the SIR. The Company reserves the right to decline requests from generators to interconnect to the distribution network system when the Company deems it necessary to protect its system, facilities, or other Customers.

If there is a change in account name for the premises on which the generator is located (<u>i.e.</u>, an RNM Host Account, a CDG Host Account, or the account of a Customer with on-site generation that does not participate in RNM or CDG), the successor Customer will be eligible for service under this Rider, subject to the Section G charges and credits applicable to its predecessor, for the remaining term of service. If there is a Customer-initiated change in the generating equipment that requires a new standardized interconnection request to be filed with the Company (<u>e.g.</u>, due to an increase in the nameplate rating or replacement of the generating facility) or a change in the type of net metering (<u>e.g.</u>, from CDG to RNM or from RNM to a single net-metered account), the account will be subject to the applicable terms and conditions of service in effect at the time of such change.
