NATIONAL GRID TARIFF FILING IN RESPONSE TO THE COMMISSION'S ORDER REJECTING TARIFF FILINGS AND DIRECTING TARIFF PROVISIONS

Dear Secretary Burgess:

The attached tariff leaf revision, issued by Niagara Mohawk Power Corporation d/b/a National Grid (the "Company"), is being transmitted for filing in compliance with the order issued and effective November 15, 2018 by the New York State Public Service Commission ("Commission") in the above case number ("Order").

Eighth Revised Leaf No. 355
To P.S.C. No. 220 Electricity
Effective: April 1, 2019

This filing is being made in compliance with Ordering Clause No. 4 of the Order, which directs the Company to make tariff amendments to eliminate the incremental customer charge under the Company's residential time-of-use rate for customers on that rate who have qualifying, registered electric vehicles. Consistent with the Order, this tariff amendment is being made on not less than 90 days' notice, to become effective on April 1, 2019. A red-lined copy of the revised tariff leaf is also provided in Attachment 1.

The Joint Utilities¹ filed a petition with the Commission on December 7, 2018 seeking a waiver of the requirement for newspaper publication of the tariff amendments directed by Ordering Clauses No. 4 and 5 of the Order² and are awaiting Commission action on such petition.
