#### RE: Case 16-E-0622, Tariff Amendments for the Shared Solar Pilot Program

Dear Secretary Burgess:

Consolidated Edison Company of New York, Inc. ("Con Edison" or the "Company") is filing with the Public Service Commission (the "Commission") amendments to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Tariff"), applicable to its customers in the City of New York and the County of Westchester.

The revised Tariff Leaves, which are identified below, are filed to become effective on November 13, 2018:

### **Background**

On November 30, 2017, the Company filed an implementation plan, including draft tariff leaves, for the Shared Solar Pilot Program applicable to its low-income Customers ("Implementation Plan").

The Company made the following proposals in the draft tariff leaves included in the Implementation Plan:

- A Special Provision was added to SC 1 stating that Customers who are enrolled in the Company's low-income program may qualify to receive credits under the Shared Solar Pilot Program with eligibility, enrollment, and credit amounts determined per the Implementation Plan.
- The Monthly Adjustment Clause ("MAC") was amended to include a mechanism to recover Shared Solar Pilot Program costs in exceedance of the value of solar generation, provided the bank of credits has been exhausted, as described in the Implementation Plan.

# **Reason for Filing**

The Commission's <u>Order Approving Shared Solar Pilot Program Implementation Plan With Modifications</u>, issued and effective on September 12, 2018, in Case 16-E-0622 (the "Order"), directed the Company to make a tariff filing effectuating the MAC cost recovery and shared solar crediting mechanism consistent with the draft tariff leaves included in the Implementation Plan, with modifications.

## Tariff Changes

Pursuant to the Order, the Company is issuing revised Tariff Leaves based on the draft tariff leaves included in the Implementation Plan, with the following modifications:

- Case number citations have been corrected.
- References to specific Implementation Plan dates have been eliminated since the Implementation Plan will be regularly updated.

### **Conclusion and Notice**

Pursuant to Ordering Clause 8 of the Order, the Company is filing these Tariff changes within 60 days of the effective date of the Order, to become effective on not less than one day's notice. Pursuant to Ordering Clause 9 of the Order, the Commission waived the requirement for newspaper publication of these changes.
