**Re: Case No. 09-M-0311 - Tariff Amendments Removing Language Associated with the  
Temporary State Assessment**

Dear Secretary Burgess:

Consolidated Edison Company of New York, Inc. (the “Company”) is filing with the New York State Public Service Commission (“Commission”) amendments to its Schedule for Gas Service, P.S.C. No. 9 – Gas (“Gas Tariff”). Appendix A identifies the tariff leaves being filed to become effective January 19, 2018.

The Commission’s Order Approving Temporary State Assessment Tariff Amendments (the “Order”), issued and effective December 19, 2017, in Case 09-M-0311, “Implementation of Chapter 59 of the Laws of 2009 Establishing a Temporary Annual Assessment Pursuant to Public Service Law §18-a(6)” required utilities to file tariff revisions and/or cancellation supplements within 30 days of the issuance of the Order to remove all language associated with the Temporary State Assessment (“TSA”) due to the expiration of the TSA effective after December 31, 2017.<sup>1</sup> Accordingly, the Company has removed the TSA language from all applicable sections of the Gas Tariff.

As directed by Ordering Clause 2 of the Order, the Company is filing changes to the Gas Tariff to become effective on not less than one day’s notice.

As specified in Ordering Clause 5 of the Order, the Commission has waived the requirements for newspaper publication.
