#### Purpose of the Filing

The Companies are filing tariff amendments in compliance with Ordering Clause No. 2 of the Order to implement a Revenue Decoupling Mechanism ("RDM") for street lighting customers.

# <u>Overview</u>

The revisions reflected in the attached amendments to the Companies tariffs implement a RDM in accordance with the Companies' Joint Proposal that was approved by the Commission in June 2016<sup>1</sup>, and the Order. The implementation of the RDM was contingent upon the approval of a Company-owned LED offering for street lighting customers.

The RDM will apply to all service classes under each Company's Street Lighting tariff Schedule. The RDM Adjustment will apply to lamp charges or volumetric delivery charges, as applicable.

## **Publication**

In accordance with Ordering Clause No. 3, requirements for newspaper publication pursuant to Section 66(12)(b) of the Public Service Law and 16 NYCRR 720-8.1 for the tariff revisions are waived.
