The Order directed utilities to file tariff leaves implementing the Value of Distributed Energy Resources (VDER) Phase One Value Stack consistent with the requirements and discussion set forth in the body of the Order. The Order also directed utilities to file monthly VDER tariff statements incorporating the requirements listed in the templates in Appendix D-Value of Distributed Energy Resource Statement and Appendix G – Value of Distributed Energy Resource Value Stack Credits Statement. The enclosed leaves and statements comply with these directives. The tariff leaves and statements were directed to be filed on not less than 15 days' notice to become effective on November 1, 2017.

Ordering Clause 23 of the Order waived the requirements of Public Service Law §66(12)(b) and 16NYCRR §720-8.1 as to newspaper publication of the tariff amendments described in Ordering Clause No. 1 and Ordering Clause No. 2.
