Dear Secretary Burgess:

Enclosed is an electronic version of Monthly Gas Supply Charge Statement No. 2 applicable to Service Classification Nos. 1, 2, 3, 9, and 10, and Delivery Adjustment Charge Statement No. 2 applicable to Service Classification Nos. 1, 2, 3, 4, 5, 7, 8, 9, 10 and 15 of our Rate Schedule P.S.C. No. 9 – Gas. The Monthly Gas Supply Charge Statement No. 2 and the Delivery Adjustment Charge Statement No. 2 will be effective commencing with gas used on or after June 1, 2017.

The estimated amount related to surcharges and credits included in NGS & DAC Statements No. 2 is \$1,021,000 based on estimated sales of 16,140,000 Ccf. The estimated effect on revenue, exclusive of surcharges and credits, is an increase of \$370,700 on a monthly basis.

The surcharge calculation for June 2017 Intermediate Pipeline Stranded Capacity Surcharge pursuant to General Information Section 0, Leaf Nos. 138 & 139 of P.S.C. No 9 – Gas results in a unit surcharge of \$0.00000/Mcf is applicable for June 1, 2017 through June 30, 2017.

The surcharge calculation for June 2017 Upstream Pipeline Stranded Capacity Surcharge pursuant to General Information Section 0, Leaf Nos. 137 & 138 of P.S.C. No 9 – Gas results in a unit surcharge of \$0.00000/Mcf is applicable for June 1, 2017 through June 30, 2017.

In addition, Deficiency Imbalance Sales Service Rate Statement No. 2, Demand Transfer Recovery Rate Statement No. 2, Gas Transportation Statement No. 2, Natural Gas Vehicle Statement No. 2, Standby Sales Service Rate Statement No. 2, Transportation Sales Service Rate Statement No. 2, Reserve Capacity Cost Statement No. 2, Weather Normalization Clause Multipliers Statement No. 2, Distributed Generation Statement No. 2, Merchant Function Charge Statement No. 2, Incremental Monthly Gas Supply Charge Statement No. 2, Low Income Customer Affordability Assistance Program Statement No. 2, Mandatory Upstream Transmission Capacity (“MUTC”) Statement No. 2, Temporary State Assessment Charge (“TSA”) Statement No. 2, Conservation Incentive Programs Cost Recovery (“CIPs”) Statement No. 2, and Regulatory Tracking Charge (RTC) Statement No. 2.
