Dear Secretary Burgess:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation (“NYSEG”) and Rochester Gas and Electric Corporation (“RG&E”), (together the “Companies”) are transmitted for filing in compliance with the New York Public Service Commission’s (the “Commission”) Order On Net Energy Metering Transition, Phase One of Value of Distributed Energy Resources, and Related Matters, issued and effective on March 9, 2017 (the “Order”), in the above-referenced proceedings. The list of revised tariff leaves is provided in Attachment A. The tariff leaves will become effective on April 27, 2017.

**Purpose and Overview of Filing**

The Companies are filing revisions to its tariffs<sup>1</sup> to separate requirements applicable to Phase One Net Energy Metering (“Phase One NEM”) from existing net energy metering requirements. More specifically, the Companies have established a new section in its tariff to implement the transition from net energy metering to the Value of Distributed Energy Resources Phase One NEM.

The Companies have also included revisions to identify the minimum and maximum total rated generating capacity of interconnected projects to be served under the existing net energy metering rules, prior to Phase One NEM.

**Publication**

In accordance with Ordering Clause No. 1, the requirements of Section 66(12)(b) of the Public Service Law regarding newspaper publication are waived.
