Proceeding on Motion of the Commission as to the Rates, Charges, Rules and

Regulations of National Fuel Gas Distribution Corp. for Gas Service

Dear Secretary Burgess:

In compliance with Ordering Clause 3 of *Order Establishing Rates for Gas Service*, issued and effective on April 20, 2017 ("Rate Order") in the above referenced case, National Fuel Gas Distribution Corporation ("Distribution" or the "Company") submits revised tariff leaves for its tariff, P.S.C. No. 9-GAS. The tariff leaves submitted in the instant filing, set forth in Attachment A, are issued as of today on not less than one day's notice and have an effective date of May 1, 2017.

This is the second of several filings the Company anticipates in order to effectuate the provisions adopted by the Rate Order. The changes to Meters and Regulators General Information tariff leaves address the disposition of the Company's Local Production proposals as discussed on pages 83-85 of the Rate Order. The other tariff leaves included with the instant filing address the disposition of the Retail Access – Deficiency Imbalance Charges matters as discussed on pages 95-97 of the Rate Order. Included with these changes is language added to the Cash Out Index for Imbalance Resolution General Information section requested in Department of Public Service Staff testimony that clarifies how charges for non-performance are classified between gas costs and penalties. Additionally, the submitted tariff leaves contain non-substantive changes, primarily to the information lines in the header at the top of each page that indicate basic information about each page.

Consistent with Ordering Clause 6 of the Rate Order, the requirements of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 that newspaper publication be completed prior to the effective date of the proposed supplement is waived.
