Dear Secretary Burgess:

Enclosed is an electronic version of Monthly Gas Supply Charge Statement No. 17 applicable to Service Classification Nos. 1, 2, 3, 9, and 10, and Delivery Adjustment Charge Statement No. 17 applicable to Service Classification Nos. 1, 2, 3, 4, 5, 7, 8, 9, 10 and 15 of our Rate Schedule P.S.C. No. 9 – Gas. The Monthly Gas Supply Charge Statement No. 17 and the Delivery Adjustment Charge Statement No. 17 will be effective commencing with gas used on or after September 1, 2018.

The estimated amount related to surcharges and credits included in NGS & DAC Statements No. 17 is \$446,000 based on estimated sales of 10,790,000 Ccf. The estimated effect on revenue, exclusive of surcharges and credits, is an increase of \$318,500 on a monthly basis.

The surcharge calculation for September 2018 Intermediate Pipeline Stranded Capacity Surcharge pursuant to General Information Section 0, Leaf Nos. 138 & 139 of P.S.C. No 9 – Gas results in a unit surcharge of \$0.00010/Mcf is applicable for September 1, 2018 through September 30, 2018.

The surcharge calculation for September 2018 Upstream Pipeline Stranded Capacity Surcharge pursuant to General Information Section 0, Leaf Nos. 137 & 138 of P.S.C. No 9 – Gas results in a unit surcharge of \$0.00000/Mcf is applicable for September 1, 2018 through September 30, 2018.

In addition, Deficiency Imbalance Sales Service Rate Statement No. 17, Demand Transfer Recovery Rate Statement No. 17, Gas Transportation Statement No. 17, Natural Gas Vehicle Statement No. 17, Standby Sales Service Rate Statement No. 17, Transportation Sales Service Rate Statement No. 17, Reserve Capacity Cost Statement No. 17, Weather Normalization Clause Multipliers Statement No. 17, Distributed Generation Statement No. 17, Merchant Function Charge Statement No. 17, Incremental Monthly Gas Supply Charge Statement No. 17, Low Income Customer Affordability Assistance Program Statement No. 17, Mandatory Upstream Transmission Capacity ("MUTC") Statement No. 17, and Conservation Incentive Programs Cost Recovery ("CIPs") Statement No. 17.

In connection with this filing, the Company is also required to submit information that contains

trade secrets. Accordingly, the Company has filed the required information with the Department Records Access Officer, together with a request for trade secret protection under the Commission's regulation.
