Re: Case 18-E-0018 – In the Matter of Proposed Amendments to the New York State Standardized Interconnection Requirements (SIR) for Small Distributed Generation.

Dear Secretary Burgess:

New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E"), (together the "Companies") are transmitting for filing in compliance with the New York Public Service Commission's (the "Commission") Order Granting Clarification (the "Order"), in the above referenced proceeding.

A list of the revised tariff leaves is provided as Appendix A. The tariff leaves will become effective on July 19, 2018.

**Purpose of Filing**

The Companies are filing tariff amendments in compliance with Ordering Clause No. 1 to incorporate the revised SIR Addendum and to remove inconsistent tariff provisions.

As provided in the Order, the SIR Addendum was revised to include recommended updates filed by the Department of Public Service Staff in response to the Commission's directives in the Value of Distributed Energy Resources ("VDER") Implementation Order.<sup>1</sup>

The Companies are also making revisions to its tariffs to update provisions to be consistent with the Order. More specifically, the Companies are modifying P.S.C. Schedule No. 119, Rule No. 9, and P.S.C. Schedule No. 19, Rule No. 10, "Distributed Generation Interconnection Requirements" to be "Distributed Energy Resource (DER) Interconnection Requirements".

Newspaper Publication

In accordance with Ordering Clause No. 2, the requirements of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 requiring newspaper publication have been waived.
