Dear Secretary Burgess,

Pursuant to the Public Service Commission's order in the above-captioned proceeding, enclosed herewith are the following materials, issued and transmitted for filing on behalf of the Massena Electric Department ("MED" or "Department"), in accordance with the requirements of the Public Service Commission ("Commission").

1. Revised Tariff leaf for P.S.C. No. 2, Electricity, clarifying provisions to govern the eligibility and terms for High Density Load Customers under Individual Service Agreements available under Service Classification No. 8: Revised Leaf No. 34, Revision 3

These revisions are issued as of July 13, 2018 and are proposed to be effective July 17, 2018.

On April 6, 2018, MED filed with the Commission proposed revisions to MED's Service Classification No. 8. MED complied with the newspaper publication requirements of PSL § 66(12)(b), with the publication of the proposed tariff changes in the local newspaper for four consecutive weeks starting on May 30, 2018. On July 12, 2018, the Commission approved MED's tariff changes and authorized them to become effective on July 17, 2018, pending MED's filing of further revisions consistent with the order.<sup>1</sup>

To maintain consistency with tariff language regarding high density load ("HDL") customers as applicable in Generic Tariff Rider A of the New York Municipal Power Agency ("NYMPA"), the Commission's July 12, 2018 Order directed MED to amend its tariff revisions so that eligibility of customers under MED's HDL provisions conforms with eligibility under NYMPA's HDL provisions. As such, MED submits today its amended tariff language to clarify that customers taking service under its HDL program must have a maximum demand exceeding 300 kW, in addition to other program requirements as approved by the Commission in its July 12, 2018 Order. The amended language conforms to the NYMPA HDL language in Generic Tariff Rider A and complies with the Commission's July 12, 2018 Order.

In accordance with the Commission's July 12, 2018 Order, the newspaper publication requirements of PSL § 66(12)(b) are waived<sup>2</sup> for this compliance filing.
