Dear Secretary Burgess:

The enclosed tariff leaves issued by New York State Electric & Gas Corporation (“NYSEG”) and Rochester Gas and Electric Corporation (“RG&E”), (together the “Companies”) are transmitted for filing in compliance with the New York Public Service Commission’s (the “Commission”) Order Adopting Program Changes with Modifications and Making Other Findings, issued and effective on April 23, 2018 (the “Order”), in the above referenced proceedings. The list of tariff leaves is included in Attachment A and they will become effective on May 1, 2018.

**Purpose of Filing**

The Companies are filing amendments to its tariffs in compliance with Ordering Clause No. 1 of the Order.

The amendments reflect an increase of the incentive payment rates for the Commercial System Relief Program (“CSRP”) and the Distribution Load Relief Program (“DLRP”) as approved by the Order. Additionally, the Order approved the Companies proposal to revise its tariffs to provide more flexibility within the Direct Load Control Program (“DLC”). Beginning 45 days prior to the next summer capability period, the Companies will file a statement that provides the proposed payment rates, eligibility criteria regarding its DLC Program offerings.
