Purpose of Filing

The Companies are submitting tariff revisions in compliance with Ordering Clause No. 1 of the Order to revise the treatment of banked credits when a Satellite Account is closed or cancelled.

Overview

The Companies have modified their tariffs to provide for the reallocation of a Satellite Account's banked credits when the Satellite Account is closed or has discontinued participation in a CDG project. When a final bill is produced for a Satellite Account, any remaining banked credits will be transferred to the Host's account without any adjustments to the Market Transition Credit or Community Credit<sup>1</sup>. Once the Company has transferred the banked credits to the Host Account, the Company is no longer responsible for providing any additional refunds or credits to the Satellite Account.

In accordance with Ordering Clause No. 3 of the Order, newspaper publication in accordance with Public Service Law 66(12)(b) and 16 NYCRR 720-8.1 is waived.
