Purpose of Filing

The Companies are submitting tariff revisions in compliance with Ordering Clause No. 1 of the Order for the 2021 summer capability period.

Overview

In accordance with the Order, the Companies' revised its tariffs to remove the enrollment deadline of June 1, with a start date of July 1, in the Distribution Load Relief Program and the Commercial System Relief Program. A customer that wants to participate will need to apply by April 1 for a May 1 commencement date, or by May 1 for a June 1 commencement date.

Additionally, customers participating in the Distribution Load Relief Program and the Commercial System Relief Program will not receive any credit for performance during the Capability Period if they fail to establish communication prior to the end of the Capability Period.

Lastly, for the 2021 Capability Period only, aggregators that revise their kW pledged to the programs that result in a lower kW, the new kW of contracted Load Relief will be used for Performance Factor and Reservation Payment calculation purposes for the entire Capability Period. Otherwise, the new kW of contracted Load Relief will be applied beginning the next month.

Newspaper Publication

In accordance with Ordering Clause No. 3 of the Order, newspaper publication in accordance with Public Service Law 66(12)(b) and 16 NYCRR 720-8.1 is waived.
