Purpose of Filing

The Company is submitting the tariff filing to cancel the leaves associated with the Energy Smart Community ("ESC") Rate Pilot.

The ESC Rate Pilot was approved to be implemented on a pilot basis to measure customer adoption and impacts of time varying rates. Customers who are currently enrolled in the ESC Rate Pilot will be transitioned back to their previous pricing option, or can select another available option, as of November 1, 2021.

The Companies request that the Commission waive newspaper publication in accordance with Public Service Law 66(12)(b) and 16 NYCRR 720-8.1 as this Program is for a limited population of the Companies customers.
