Dear Secretary Phillips:

New York American Water hereby submits System Improvement Charge Statement No. 7 to Tariff, P.S.C. No. 5 – Water, effective August 1, 2021. The Commission's Order Establishing Rates for Water Service issued May 18, 2017 in the above referenced matter adopted the provision of the Joint Proposal that provided for the SIC surcharge to go into effect 60 days after submittal unless Staff submits a letter to the Company indicating that the proposed surcharge should be adjusted.

The purpose of this letter is to outline the expenditures that New York American Water has completed as part of the System Improvement Charge ("SIC") program, as authorized pursuant to the Commission's Orders in Case 16-W-0259, Issued and Effective May 18, 2017, and February 6, 2020, and to request the implementation of a surcharge to recover costs related to the SIC program.

As set forth in Exhibits A, B, and C, the total expenditures made to date for the projects included in this filing are \$18,840,058 with no asset retirements. Also included in this filing is the reconciliation of the over/under collection of SIC for the period ended 7/31/2021 totaling \$246,943 in Attachments B and C.
