Tariff Compliance Filing

Dear Secretary Phillips:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E"), (together the "Companies"), are being transmitted for filing in compliance with the New York State Public Service Commission's *Order Approving Electric and Gas Rate Plans in Accord With Joint Proposal, with Modifications* (the "Order"), issued and effective November 19, 2020, in the above-referenced proceedings. This filing is also made in accordance with Appendix 7-H (electronic tariff filing system) of the New York State Public Service Commission's ("PSC" or "Commission") Codes, Rules and Regulations (16 NYCRR Appendix 7-H). Purpose of Filing

The purpose of this filing is to provide clarifications and minor corrections to the Companies' initial compliance filing submitted November 25, 2020, in the above-referenced proceedings. After discussions with DPS Staff, the Companies have made the revisions identified below. These revisions are proposed to become effective on March 20, 2021:

- The Companies are clarifying provisions in the Gas Interruptible Sales and Interruptible Transportation Service Classifications.
- The Companies removed reference to the Reliability Support Services Surcharge and clarified that Rate Year 1 was through April 30, 2021 for the Revenue Decoupling Mechanism.
- NYSEG is filing Leaf No. 53 in PSC No. 119 to update the provision for the Automated Meter Infrastructure ("AMI") as set forth in Appendix O of the Joint Proposal.
- RG&E is filing certain tariff leaves to correct pricing: Leaf No. 27 in PSC No. 18 to revise the price for Rate Year 2 for Davit pole (30-35 ft.) supporting a MV luminaire (1000W max.), Leaf No. 29 in PSC No. 18 to revise several prices and Leaf No. 211 in PSC 19 to revise the Minimum Delivery Demand Charge for Rate Year 1, 2 and 3. Additionally, the Companies are filing tariff leaves that identify the delivery charges for the service classes where delivery discounts are available for the Excelsior Jobs program.
- NYSEG inadvertently deleted provisions related to the Demand Cost Adjustment and Reservation of Sales Status in PSC No. 88. These provisions have been restored.

Newspaper Publication

Ordering Clause No. 7 of the Order requires the Companies to publish an advertisement of the tariff amendments for Rate Year 1. The Companies are requesting waiver of newspaper publication for the instant filing and the compliance filing submitted December 18, 2020, because the Companies completed newspaper publication revisions for Rate Year 1 and these filings address minor corrections and housekeeping changes.
