RE: Case 19-E-0464, Tariff filing by Consolidated Edison Company of New York, Inc. to Modify Its Electric Tariff Schedule, P.S.C. No. 10 and P.S.C. No. 12 – PASNY, to Establish Provisions for Value Stack Compensation for Its PASNY Customers

Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. (the "Company") is filing with the Public Service Commission (the "Commission") amendments to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Electric Tariff"), applicable to its customers in the City of New York and the County of Westchester. The Company is also filing amendments to its Schedule for PASNY Delivery Service, P.S.C. No. 12 – Electricity (the "PASNY Tariff"), applicable to delivery by the Company of power and associated energy to Authority Public Customers under the PASNY Tariff.

The revised Electric Tariff and PASNY Tariff Leaves, identified in Appendix A, are filed to become effective on November 1, 2019.

Reason for Filing

On June 18, 2019, the Company filed tariff amendments to enable customers taking service under the PASNY Tariff to receive value stack compensation as established within the Commission's proceeding *In the Matter of the Value of Distributed Energy Resources*.² The instant filing is being made pursuant to the Commission's *Order Approving Tariff Amendments*

<u>with Modifications</u> issued October 17, 2019 in Case 19-E-0464 (the "Order"). The Order approved the tariff amendments filed on June 18, 2019, with minor modifications to ensure consistency between the Electric Tariff and PASNY Tariff.

Tariff Changes

Pursuant to the Order, the Company is filing changes to the Electric Tariff and PASNY Tariff to: (1) define the terms "net consumption" and "net hourly consumption," (2) clarify that Out of Market Environmental Credits are recovered from the service classifications of the customers receiving the credits, and (3) clarify that the Electric Tariff Value Stack Credit Statement will be applicable to the PASNY Tariff.

In addition, the Company is making housekeeping changes to certain leaves included in the June 18, 2019 filing that were subsequently changed, effective July 1, 2019, as approved by the Commission in Case 15-E-0751.

As directed by Ordering Clause No. 2 of the Order, the Statement of Value of Distributed Energy Resources Value Stack Credits of the Electric Tariff will be filed separately with an effective date of November 1, 2019, and will include changes to clarify that it will also be applicable to the PASNY Tariff.

Conclusion and Notice

As directed by Ordering Clause No. 3 of the Order, the requirements of Public Service Law §66(12)(b) and 16 NYCRR §720-8.1 as to newspaper publication of the tariff revisions are waived. The Company is filing changes to the Electric Tariff and PASNY Tariff, on not less than five days' notice to become effective November 1, 2019.
