Purpose of Filing

In accordance with Ordering Clause No. 1 of the Order, the Companies are filing amendments to its tariff schedules to remove language referencing “prospective basis only”. When a written agreement is provided to NYSEG or RG&E, the Company will file a revised Tax Surcharge Percentages (TSP) Statement with the Commission on not less than 15 days’ notice.
