RE: Case No. 16-M-0330, Petition of CTIA – The Wireless Association to Initiate a Proceeding to Update and Clarify Wireless Pole Attachment Protections

Dear Secretary Burgess:

Consolidated Edison Company of New York, Inc. ("Con Edison" or the "Company") is filing with the Public Service Commission (the "Commission") amendments to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Tariff"), applicable to its customers in the City of New York and the County of Westchester.

The revised Tariff Leaf, which is identified below, makes changes to Rider K of the Tariff and has an effective date of October 1, 2019:

Reason for Filing

This filing is made pursuant to the Commission's <u>Order Allowing Wireless Pole Attachment Rates to go into Effect on a Temporary Basis</u> (the "Order"), issued and effective September 20, 2019 in the above-referenced proceeding. The Order directed all electric and telephone utilities subject to the jurisdiction of the Commission to file tariff amendments setting rates for new wireless pole attachments.

Background

In compliance with the Commission's March 14, 2019 Order in this proceeding, the Commission ordered New York State electric utilities to file tariff amendments establishing rates for wireless pole attachments. In its compliance filing made on June 12,

2019, the Company established a rate for wireless pole attachments and also proposed an update to its span wire pole attachment rates in its filing made in compliance with that order. The Commission subsequently suspended the effective date of the compliance filing through and including November 28, 2019. The Order is allowing the Company to file a wireless pole attachment rate to become effective October 1, 2019 while the span wire pole attachment rate continues to be reviewed.

Tariff Changes

The Company proposes to update Rider K of the Tariff to establish the charge applicable to new wireless pole attachments. The Company has calculated the charge for new wireless pole attachments to be \$32.39 multiplied by the number of feet occupied. The number of feet occupied: (1) will reflect the overall length of the equipment and mounting hardware, plus six inches, rounded to the next whole foot; and (2) will exclude conduits, risers, and electrical meters.

Consistent with the Order, the rate used to determine the annual pole attachment charge was formulated using the Federal Communications Commission's cable formula for horizontal cable attachments and reflects the 2018 Con Edison pole attachment cost. Work papers detailing the computation of the revised rate used to determine the annual pole attachment charge are enclosed.¹

Conclusion and Notice

Pursuant to Ordering Clause 1 of the Order, the Company is filing changes to the Tariff on not less than five days' notice to become effective October 1, 2019. Pursuant to Ordering Clause 2, the Commission has waived the requirements for newspaper publication.
