RE: Cancellation Supplement and Revised Tariff Leaves in Case No. 18-G-0730,  
*Minor Rate Filing of Valley Energy, Inc. to Increase Its Annual Revenues by  
About \$300,000 or 18.9% in Total Revenues.*

Dear Secretary Burgess:

Pursuant to the Public Service Commission's ("Commission") order in the above referenced case, Valley Energy Inc. submits the attached supplement and amended tariff leaves to the Company's Gas Tariff, P.S.C. No. 1.<sup>1</sup>

On November 28, 2018, Valley Energy Inc. ("Company") filed with the Commission Third Revised Leaf Nos. 88, 95 and 102 in support of its filing to revise rates and charges in its tariff. Subsequently, the Company filed Supplement Nos. 5, 6, 7 and 8 to postpone the effective date of the revised tariff leaves finally to September 1, 2019, so as to correct certain deficiencies and provide additional workpapers and data to Department of Public Service Staff. On August 14, 2019, the Commission issued its Order approving new rates and terms, and requiring the Company to submit a cancellation supplement on the previously filed proposed tariff leaf revisions in addition to certain other revisions to additional tariff leaves.
