Dear Secretary Burgess:

The enclosed tariff leaves issued by New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E"), (together the "Companies") are transmitted for filing in compliance with the New York Public Service Commission's (the "Commission") Order on Value Stack Eligibility Expansion and Other Matters, issued and effective on September 12, 2018 (the "Order"), in the above-referenced proceedings. The list of tariff leaves is included as Attachment A and they will become effective on May 1, 2019.

Purpose of Filing

The Companies are filing amendments to its tariffs after discussions with Staff to allow for stand- alone Storage to be the generation technology for the Host Account and qualify to participate in Community Distributed Generation ("CDG") or Remote Net Metering ("RNM").

The Companies have removed RNM from the individual electric generating equipment net metering provisions and have separately identified RNM as its own separate rule within the tariff schedule to more efficiently describe RNM for multiple technologies, including stand-alone storage. These revisions will also make NYSEG and RG&E's tariffs more consistent with the other electric utilities in the State.
