Dear Secretary Phillips:

Enclosed is an electronic version of Monthly Gas Supply Charge Statement No. 44 applicable to Service Classification Nos. 1, 2, 3 and 10, and Delivery Adjustment Charge Statement No. 44 applicable to Service Classification Nos. 1, 2, 3, 4, 5, 7, 8, 10 and 15 of our Rate Schedule P.S.C. No. 9 – Gas. The Monthly Gas Supply Charge Statement No. 44 and the Delivery Adjustment Charge Statement No. 44 will be effective commencing with gas used on or after December 1, 2020.

The estimated amount related to surcharges and credits included in NGS & DAC Statements No. 44 is \$739,000 based on estimated sales of 71,350,000 Ccf. The estimated effect on revenue, exclusive of surcharges and credits, is a decrease of \$1,718,500 on a monthly basis.

The calculation for the Intermediate Pipeline Stranded Capacity Surcharge, pursuant to General Information Section 0, Leaf Nos. 138 & 139 of P.S.C. No 9 – Gas, results in a unit surcharge of \$0.00000/Mcf effective December 1, 2020 through December 31, 2020.

The calculation for the Upstream Pipeline Stranded Capacity Surcharge, pursuant to General Information Section 0, Leaf Nos. 137 & 138 of P.S.C. No 9 – Gas results in a unit surcharge of \$0.00000/Mcf effective December 1, 2020 through December 31, 2020.
