Dear Secretary Phillips:

In accordance with the *Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans* (issued and effective March 15, 2018) in Cases 17-E-0238 and 17-G-0239 (the "Order"), Niagara Mohawk Power Corporation d/b/a National Grid (the "Company") submits for filing the electric tariff leaves listed on Attachment A for P.S.C. No. 220 for Electric Service – Electricity.

The Company filed tariff changes on February 28, 2020 in compliance with Ordering Clause No. 6 of the Order, which directed the Company to file further tariff changes as are necessary to effectuate the rate year three rates as approved and provided for in the Order. However, on March 25, 2020, the Commission issued an *Order on Postponing Approved Electric and Gas Delivery Rate Increases and Temporarily Waiving Certain Tariff Fees* ("Postponement Order") directing the Company to file a supplemental postponement of the February 28, 2020 tariff leaves until July 1, 2020.

In addition, on May 29, 2020, the Commission issued a subsequent *Order Further Postponing Approved Electric and Gas Delivery Rate Increases and Updated Reduction to the Low Income Discount Credits* ("Further Postponement Order") directing the Company to file a second supplemental postponement until August 1, 2020. These further tariff changes are filed to replace the February 28, 2020 tariff leaves with updated information on not less than 30 days' notice to be effective on a temporary basis on August 1, 2020.
