### Overview of the Filing

Concurrent with this filing and as directed by the Commission's <u>Order Directing Negotiation</u> of a Reliability Support Service Agreement, issued on November 14, 2014 in Case 14-E-0270 ("Order"), the Company is filing its Response and Petition for Approval of Cost Allocation and Cost Recovery Surcharge Mechanism (the "Petition").

The Order directed RG&E and R.E. Ginna Nuclear Power Plant, LLC ("Ginna") to file with the Commission a Reliability Support Services Agreement ("RSSA") for the continued operation of the R.E. Ginna Nuclear Power Plant in support of electric system reliability on the bulk transmission system.<sup>1</sup> The Company is proposing to implement an RSS Surcharge to recover costs incurred by the Company as set forth in the Petition.

#### Newspaper Publication

The Company respectfully requests the requirement of 66(12)(b) of the Public Service Law requiring newspaper publication be waived as customers will be informed of the revised surcharge amounts through bill messages.

A State Administrative Procedure Act Notice is enclosed for publication in the State Register.
