New York State Electric & Gas Corporation (“NYSEG”) and Rochester Gas and Electric Corporation (“RG&E”) (together the “Companies”) hereby transmit for filing the enclosed tariff leaves in compliance with the requirements of the New York State Public Service Commission (“Commission”) and Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

**Purpose of the Filing**

On August 26, 2014, the Companies filed tariff amendments to become effective January 1, 2015, which allows for the installation of alternative communication devices for daily metering, and to update notification requirements in conformance with the Uniform Business Practices.<sup>1</sup> A postponement supplement was subsequently filed on December 2,

2014 requesting the amendments to become effective on February 1, 2015. The Commission issued an Order approving the amendments on January 8, 2015.

The three tariff leaves listed above were also revised as a part of Case Nos. 14-G-0131<sup>2</sup> and 14-M-0512<sup>3</sup> and subsequently approved on October 3, 2014 and January 8, 2015 respectively. The updated revisions herein consolidate these filings to ensure the tariffs reflect the information correctly.

Newspaper Publication

The Companies request that the requirement of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 as to newspaper publication be waived as these revisions will not materially impact the Company's customers.
