**RE: Case 13-E-0030, Con Edison Electric Rate Case**

Dear Secretary Burgess:

Consolidated Edison Company of New York, Inc. (“Con Edison” or the “Company”) is filing with the Public Service Commission (the “Commission”) an amendment to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the “Electric Tariff”), applicable to its customers in the City of New York and the County of Westchester.

On December 2, 2014, the Company filed tariff changes as required by the Commission’s Order Approving Electric, Gas and Steam Rate Plans in Accord With Joint Proposal, issued and effective February 21, 2014, in Case 13-E-0030 et al. (the “Order”), applicable to the second rate year commencing January 1, 2015 (Rate Year 2 or “RY 2”) of the two-year rate plan approved by the Order as well as base rates that will be in effect after the end of RY 2 absent a new rate plan.

This filing corrects Electric Tariff Leaf 351, which was filed by the Company on December 2, 2014, and incorrectly stated the Service Classification (“SC”) 1 allowed revenue target under the Revenue Decoupling Mechanism (“RDM”) for RY 2. The Company erroneously backed out \$50 million low-income customer charge discounts from the target, instead of the correct \$47.5 million. The SC 1 target was, thus, \$2.5 million too low. Accordingly, the Company’s Electric Tariff Leaf, identified below, is being issued to become effective on February 4, 2015, to correct the SC 1 target:

No change is required either to the RDM allowed pure base revenue targets in the other SCs of the Electric Tariff or the RDM allowed pure base revenue target in the PASNY Tariff.

**Conclusion and Notice**

Pursuant to Ordering Clause 5 of the Order, this filing is being made on not less than 30 days' notice to go into effect on a temporary basis on February 4, 2015.

The Company requests waiver of newspaper publication of this change. The Company published notice of the RY 2 tariff changes issued on December 2, 2014, on December 9, 16, 23, and 30, 2014. Copies of this filing are being sent electronically to the active party list in 13-E-0030.
