The attached System Benefits Charge (“SBC”) Statement issued by Niagara Mohawk Power Corporation d/b/a National Grid (the “Company”) is being transmitted for filing in compliance with the Commission’s orders in Case 10-M-0457-SBC IV and Case 07-M-0548-Energy Efficiency Portfolio Standard (“EEPS”).

Statement of System Benefits Charge No. 24

To P.S.C. No. 214 Electricity

Effective: January 1, 2014

**Purpose of Filing:**

The purpose of this filing is to establish the SBC Factor No. 24, effective January 1, 2014 through December 31, 2014, in accordance with Rule No. 41-Adjustment of Charges Pursuant to the System Benefits Charge of PSC No. 220 Electricity.

**1. Case 10-M-0457-SBC IV**

The Company is proposing the following SBC collection amounts for calendar year 2014:

1. SBC IV - \$15,604,264 in accordance with the Commission’s order issued October 24, 2011.
2. \$101,750 added to collection amount for 2014 as a result of a billing adjustment in August 2012.
3. An under-collection amount of \$1,640,503 for calendar year 2013.

The total collection amount, per Attachment 1, Page 2 of 3, Line 6, including the under-collection amount, is \$17,346,517 with a rate of adjustment effective January 1, 2014 through December 31, 2014 of \$0.000653.

**2. Case 07-M-0548-EEPS**

The Company is proposing the following SBC EEPS collection amounts for calendar year 2014.

1. \$110,501,644 – In accordance with the Commission's order issued October 25, 2011.
2. \$1,062,265 – In accordance with the Commission's order issued October 23, 2009.
3. \$168,863 added to collection amount for 2014 as a result of a billing adjustment in August 2012.
4. An under-collection amount of \$1,570,988 for calendar year 2013.

The total collection amount, per Attachment 1, Page 2 of 3, Line 15, including the under - collection amount, is \$113,303,760 with an EEPS SBC rate of adjustment effective January 1, 2014 through December 31, 2014 of \$0.004268.

**3. Total SBC IV/EEPS SBC Collection Rate for January 1, 2014 through December 31, 2014**

The EEPS SBC incremental rate of adjustment of **\$0.004268/kWh** has been added to the SBC IV Rate of Adjustment of **\$0.000653/kWh** to establish a total SBC total rate of adjustment of **\$0.004921/kWh** effective January 1, 2014 through December 31, 2014.
