Dear Secretary Burgess:

Enclosed is an electronic version of Monthly Gas Supply Charge Statement No. 149 applicable to Service Classification Nos. 1, 2, and 3, and Delivery Adjustment Charge Statement No. 142 applicable to Service Classification Nos. 1, 2, 3, 5, 7, 8, and 9 of our Rate Schedule P.S.C. No. 8 – Gas. The Monthly Gas Supply Charge Statement No. 149 and the Delivery Adjustment Charge Statement No. 142 will be effective commencing with gas used on or after January 1, 2014.

The estimated amount related to surcharges and credits included in Statements No. 142 & 149 is \$2,991,000 based on estimated sales of 70,800,000 Ccf. The estimated effect on revenue, exclusive of surcharges and credits, is an increase of \$1,778,000 on a monthly basis.

The surcharge calculation for January 2014 Intermediate Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.2 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.02120 /Mcf is applicable for January 1, 2014 through January 31, 2014.

The surcharge calculation for January 2014 Upstream Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.1 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.00000 /Mcf is applicable for January 1, 2014 through January 31, 2014.

The CIPS Statement No. 46 has been updated to include rates effective January 1, 2014 pursuant to General Leaf No. 148.9 of P.S.C. No. 8-Gas.

The Company's Annual Reconciliation Filing for the twelve months ended August 31, 2013, pursuant to General Leaf Nos. 78 and 81 of P.S.C. No. 8-Gas is included. The unit surcharge of \$0.2533/Mcf is applicable for the period January 1, 2014 through December 31, 2014.

The calculation for the Research and Development Funding Mechanism pursuant to Commission Order in Case 04-G-1047 is included as a workpaper. The unit surcharge of \$0.0075/Mcf is applicable for the period January 1, 2014 through December 31, 2014.

In addition, Deficiency Imbalance Sales Service Rate Statement No. 199, Demand Transfer Recovery Rate Statement No. 194, Gas Transportation Statement No. 193, Natural Gas Vehicle Statement No. 199, Standby Sales Service Rate Statement No. 199, Transportation Sales Service Rate Statement No. 201, Reserve Capacity Cost Statement No. 159, Weather Normalization Clause Multipliers Statement No. 142, Distributed Generation Statement No. 128, LIRA Minimum Charge Statement No. 103, Merchant Function Charge Statement No. 109, Incremental Monthly Gas Supply Charge Statement No. 105, Low Income Customer Affordability Assistance Program Statement No. 94, State Income Tax Credits Statement No. 74, Mandatory Upstream Transmission Capacity ("MUTC") Statement No. 57, Temporary State Assessment Charge ("TSA") Statement No. 55 and Conservation Incentive Programs Cost Recovery ("CIPs") Statement No. 46 are included.

This statement is filed in compliance with 16 NYCRR, Section 270.55. Information pertaining to section 270.55d(7) will be delivered under separate cover letter.

In connection with this filing, the Company is also required to submit information that contains trade secrets. Accordingly, the Company has filed the required information with the Department Records Access Officer, together with a request for trade secret protection under the Commission's regulation.
