**Re: Case 12-G-0202 - Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of the Niagara Mohawk Power Corporation d/b/a National Grid for Gas Service**

Dear Acting Secretary Cohen:

The tariff leaves and statements listed on Attachment A, issued by Niagara Mohawk Power Corporation, d/b/a National Grid ("Niagara Mohawk" or "the Company"), are transmitted for filing in compliance with the requirements of the Public Service Commission and the Commission's "Order Approving Electric and Gas Rate Plans in Accord with Joint Proposal" (the "Order") issued March 15, 2013 in Case 12-G-0202. Ordering Clause No. 4 directed the Company to file, on not less than one day's notice, tariff revisions necessary to effectuate the provisions adopted by the Order to take effect on a temporary basis on April 1, 2013. The Active Parties in Case 12-G-0202 are being copied on this filing.

The requirements of §66 (12) of the Public Service Law and 16 NYCRR 270.70 that newspaper publication be completed before the effective dates of the amendments were waived with respect to the rate year one tariff revisions. The Company, however, is directed to file with the Commission, within six weeks of the effective date of the amendments, proof that notice to the public of the changes proposed in the amendments and their effective date has been published once a week for four successive weeks in a newspaper having circulation in each county containing an area affected by the amendments.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR, Appendix 7-H).
