RE: Case No. 12-E-0201 – Proceeding on Motion of the Commission as to the Rates, Charges, Rules and Regulations of Niagara Mohawk Power Corporation d/b/a/ National Grid for Electric Service

Dear Acting Secretary Cohen:

The tariff leaves listed on Attachment A, issued by Niagara Mohawk Power Corporation d/b/a National Grid, are transmitted for filing in accordance with the requirements of the New York State Public Service Commission (“Commission”). The attached leaves are being issued in compliance with the Commission’s “Order Approving Electric and Gas Rate Plans in Accord with Joint Proposal” (the “Order”) in Case No. 12-E-0201 issued March 15, 2013. Ordering Clause No. 4 directed the Company to file, on not less than one day’s notice, tariff revisions necessary to effectuate the provisions adopted by this order to take effect on a temporary basis on April 1, 2013.

The requirements of §66 (12) of the Public Service Law and 16 NYCRR 270.70 that newspaper publication be completed before the effective dates of the amendments were waived with respect to the rate year one tariff revisions. The Company, however, is directed to file with the Commission, within six weeks of the effective date of the amendments, proof that notice to the public of the changes proposed in the amendments and their effective date has been published once a week for four successive weeks in a newspaper having circulation in each county containing an area affected by the amendments.

This filing is made in accordance with Appendix 7-H (electronic filing system) to the Commission’s Codes, Rules and Regulations (16 NYCRR, Appendix 7-H).
