Dear Acting Secretary Cohen:

On March 15, 2013, The Brooklyn Union Gas Company d/b/a National Grid NY ("Company") filed its annual Revenue Decoupling Mechanism reconciliation in accordance with the Commission's "Order Concerning Proposed Revenue Decoupling Mechanism" dated December 22, 2009 in the above-captioned proceeding ("December 22 Order"). Subsequent to the March 15th filing, it was determined that some of the actual delivery service revenues reported for Calendar Years 2010, 2011 and 2012 inadvertently included Gross Receipts Tax, which resulted in an overstatement of the Company's revenues in each of these years. In addition, since the time of the initial filing the Company has received updated information regarding customer accounts that were backbilled final due to Superstorm Sandy. Accordingly, the Company hereby submits the following revised Statement of Revenue Decoupling Mechanism:

Statement No. 5 – Statement of Revenue Decoupling Mechanism Schedule to Gas Service, P.S.C. No. 12-GAS Effective Date: May 1, 2013

The purpose of this filing is to revise the Statement of Revenue Decoupling Mechanism to reflect the revenue adjustments described above. *Attachment A* sets forth the revised reconciliation. The revised surcharge will be included in the Delivery Rate Adjustment for Service Classification Nos. 1B, 1BR, 1BI, 17-1B, 17-1BR, and 17-1BI effective May 1, 2013.
