Enclosed herewith are the following materials, issued and transmitted for filing on behalf of the City of Jamestown Board of Public Utilities ("BPU") in accordance with the requirements of the Public Service Commission ("Commission").

1. Revised tariff leaves for P.S.C. No. 7, Electricity, containing provisions for economic assistance for line extension as outlined in Rider No. 5:

First Revised Leaf No. 123

2. Revised tariff leaves for P.S.C. No. 7, Electricity, containing provisions and rates for Economic Development Service as outlined under Service Classification No. 6, Individually Negotiated Contract:

First Revised Leaf Nos. 124, 127-129 Fourth Revised Leaf No. 125

These revisions are issued as of June 25, 2014 and are proposed to be effective October 15, 2014.

The above proposed revisions are being made to account for fostering the BPU's industrial and commercial customer base's economic vitality. The BPU has revised Rider No. 5 of its tariff to reflect the BPU's change from the Economic Development Fund to the Business Development Fund and to add language outlining economic assistance for obsolete service replacements.

Many of the BPU's industrial and commercial customers have electric services that require both utility and customer upgrades for reliability, safety and standardization needs. The revised Rider No. 5 will outline economic assistance to help meet those needs. Additionally, the BPU has revised the provisions of its Economic Development Service under Service Classification No. 6, dealing with individually negotiated contract service. The proposed revisions are an effort by the BPU to further promote regional economic stability by enabling a wider range of industrial customers to participate. The BPU believes that by slightly lowering the monthly demand and load factor eligibility requirements, several additional existing industrial customers who significantly contribute to regional employment will be able to receive incentives designed to help them attract and retain local jobs. The BPU further believes that by supporting local job creators, all customers benefit from regional investment and electric service rate stability.

Newspaper publication will be made in accordance with the Commission's regulations. Publication will be made on four successive weeks.

Accordingly, we respectfully request that the Public Service Commission expedite approval of the requested revisions. Additionally, we request that the Public Service Commission please advise the undersigned of any action undertaken in this proceeding and also notify Jeffrey C. Genzer, Counsel to the City of Jamestown BPU, 1615 M St. NW, Suite 800, Washington D.C. 20036 (202-467-6370 and icg@dwgp.com).
