Dear Secretary Burgess:

Consolidated Edison Company of New York, Inc. ("Con Edison" or "the Company") is filing today with the New York State Public Service Commission (the "Commission") Statement of Delivery Revenue Surcharge No. 7, effective March 1, 2017.

Explanation of Filing

Pursuant to the "make whole" provision of the Joint Proposal ("JP") adopted by the Commission in Case 16-G-0061,¹ the Company will recover or refund any revenue under- or over-collections, including interest, that result from the extension of the suspension period in that case.

This filing establishes the Delivery Revenue Surcharge ("DRS"), by customer group, resulting from the extension of the suspension period in Case 16-G-0061. For those classes subject to the Revenue Decoupling Mechanism ("RDM") the surcharge (or credit), including interest, will be recovered from or returned to customers, over the ten months beginning March 2017 and will be included in the RDM Adjustments effective March 1, 2017, with the exception of the Service Classification ("SC") 2 "re-class" customers. These re-class customers are those that will move between SC 2 Rate I and Rate II due to the change in the applicability criteria, as explained in Section H.2.a. of the JP. The DRS for these customers, shown on this statement, is zero as the DRS will be recovered or credited over the nine months beginning April 1, 2017. For the SC 1 class that is not subject to the RDM, the DRS will be surcharged over the five months beginning March 1, 2017.

Summary

The Delivery Revenue Surcharge reflects delivery revenue net under-collections of \$11,887,390, consisting of \$10,938,540 related to classes subject to the RDM, with the exception of the SC 2 re-class customers as explained above, \$966,324 related to SC 1 and an offsetting over-collection of \$17,474 related to SC 2 Rider H customers.
