Dear Secretary Burgess,

Enclosed herewith are the following materials, issued and transmitted for filing on behalf of the City of Jamestown Board of Public Utilities, in accordance with the requirements of the Public Service Commission (“Commission”).

1. Revised tariff leaf for P.S.C. No. 7, Electricity, containing provisions for adding the costs of the annual renewable energy obligations (RECs), alternative compliance payments, and zero emissions credits (ZECs), pursuant to New York State’s Clean Energy Standard, outlined in Leaf 76 Revision 2, Section II(6)(b)(1)(vii), Cost of Environmental Allowances and Fees:

Second Revised Leaf No. 76.

2. Revised tariff leaves for P.S.C. No. 7, Electricity, deleting provisions for adding the costs of the annual nuclear energy requirements (purchase of ZECs), on the following leaves (which are now addressed on second revised leaf no. 76) outlined in:

Leaf 97, Revision 12,
Leaf 99, Revision 11,
Leaf 102, Revision 11, and
Leaf 125, Revision 11.

3. Revised tariff leaves for P.S.C. No. 7, Electricity, deleting provisions for adding the costs of the annual nuclear energy requirements (purchase of ZECs), on the following leaves (which are now addressed on second revised leaf no. 76) and including the provisions for the LED Lighting Rates referenced in Case No. 16-E-0523 and outlined in:

Leaf 105, Revision 14, and
Leaf 109.1, Revision 7.

These revisions are issued as of February 22, 2017 and are proposed to be effective on March 1, 2017.

Because the revisions proposed above implement a Commission-mandated program, the City of Jamestown Board of Public Utilities respectfully requests a waiver of the newspaper publication requirements of PSL § 66(12)(b).

Accordingly, we respectfully request that the Commission expedite approval of the requested revisions. Additionally, we request that the Commission please advise the undersigned of any action undertaken in this proceeding and also notify Jeffrey C.
