The enclosed statement, issued by New York State Electric & Gas Corporation ("NYSEG" or the "Company"), is transmitted for filing in compliance with the requirements of the New York State Public Service Commission ("PSC" or "Commission").

Statement of Underground Residential Distribution Contribution ("URD Statement") Effective April 1, 2017

Pursuant to the Commission Order in Case 25352, issued December 28, 1971, Case 03-E-0185, issued April 30, 2003 (the "April Order"), Case 10-E-0592, issued and effective November 23, 2010¹ (the "November 2010 Order"), and Case 11-E-0112 issued and effective June 22, 2011² (the "Central Hudson Order"), the attached new Statement of Underground Residential Distribution Contribution ("URD Statement") is being filed to reflect updated costs to NYSEG's underground residential distribution rates.

The Company has modified the calculation of the trench credit rate listed in the URD Statement based on the Commission's recent decision in Case 15-E-0560 issued and effective October 17, 20163 (the "Niagara Mohawk Order"). The trench credit rate is used for paying developers when they elect to dig the trench. NYSEG historically has calculated the trench credit to include any revenues received from other utility trench occupants, resulting in a net average cost to the
