## Dear Secretary Burgess:

In compliance with Ordering Paragraph 1 of the Public Service Commission Order, issued and effective December 16, 2016, in the above captioned proceeding ("Order"), Central Hudson Gas & Electric Corporation ("Central Hudson" or "the Company") hereby files amended tariff leaves to its Schedule for Gas Service, PSC No. 12 – Gas to become effective January 1, 2017.

The tariff amendments included herein reflect implementation of the following:

- (a). Daily communications with all interruptible customers as soon as weather forecasts project outside temperatures to be 20 degrees or below for the upcoming three consecutive days or during times when three days of consecutive customer interruptions occur;
- (b). Daily communication with interruptible customers during an interruption and, at a minimum, at least one time at the end of every interruption to remind customers to replenish alternate fuel inventories as needed to maintain minimum alternate fuel levels;
- (c). The addition of one unannounced interruption test at the end of January of each year;
- (d). Requiring affidavits attesting to compliance with Company tariffs from all interruptible customers except those customers who have elected to cease using natural gas when directed to by Central Hudson in lieu of maintaining an alternate fuel inventory; and,
- (e). Requiring that all interruptible customer affidavits include the customer's oil dealer's contact information.

Pursuant to the Order, requirements (c), (d) and (e) are applicable to customers that fail to interrupt as required by the Company's tariff.
