Purpose of Filing

The Companies are filing tariff amendments in compliance with Ordering Clause No. 1 of the Order to further revise the offset tariff provision, as discussed in the Order.

Overview

The Order directed NYSEG and RG&E to file further tariff revisions to its Standby Service Classifications to effectuate the multi-party offset tariff and reliability credit calculation provisions. With the multi-party offset tariff, a customer that owns a qualified distribution generation facility is allowed to offset its own load as well as the loads from one or more other customer accounts under different names.

The Companies were also directed to update the definition of “Summer Periods” to June 1 through September 30 and that the date by which customers must request the reliability credit, from October 1 to October 14 each year.

The Companies implemented standby reliability credit provisions as part of the Companies’ rate case compliance filing in Case 15-E-0283 and Case 15-E-0285, submitted on June 29, 2016.

Publication

In accordance with Ordering Clause No. 2 of the Order, the requirements of Section 66(12)(b) of the Public Service Law have been waived.
