No. 3 – ELECTRICITY (the "Tariff"). The revised tariff leaves and Addendum - SIR-7 are issued November 29, 2016 to become effective December 1, 2016.

Reason for Filing

The Tariff Leaves and Addendum are being filed pursuant to the Commission's <u>Order Directing Tariff Amendments</u>, issued and effective November 17, 2016 (the "Order") in the above referenced case.

The Order directed the utilities to incorporate into their electric tariffs the revised Standardized Interconnection Requirements ("SIR"), as shown in Attachment A of the Order, and to file tariff amendments necessary to increase the limit for net energy metering of farm waste electric generating equipment from 1 MW to 2 MW.

Tariff Changes

To reflect the increase to the threshold from 1 MW to 2 MW for net energy metering of farm waste electric generating equipment, the Company is filing changes to General Information Section No. 9 and 13 and Service Classification No. 15 of the Tariff.

The Company is also filing the Commission's revised SIR as Tariff Addendum SIR - 7. Addendum - SIR-7 incorporates verbatim the text of the revised "Standardized Interconnection"
