Re: Extension of Effective Date of Tariff Leaves in Case No. 15-E-0753, *Tariff Filing by Salamanca Board of Public Utilities to Establish Net Metering Services for Solar and Wind Generation for Its Residential and Non-residential Customers Under Service Classifications Nos. 1 and 2.*

Dear Secretary Burgess:

On December 23, 2015, the Salamanca Board of Public Utilities ("BPU") filed with the Commission draft new tariff leaves for PSC No. 1, Electricity containing the provisions for the purchase of electricity from new, renewable distributed generation as contained in the following:

Leaf No. 15, Revision 0

Leaf No. 16, Revision 0

These revisions were issued on December 23, 2015 and were proposed to become effective April 1, 2016. Newspaper publication regarding this filing was made in accordance with the Commission's regulations in the local newspaper on February 4, 11, 18 and 25, 2016.

The BPU consulted with Department of Public Service Staff, and Staff recommended certain revisions to the tariff along with a revised effective date. Pursuant to Staff's recommendation, the filing was subsequently postponed to May 1, 2016 to allow for further review and discussion between the BPU and Staff. As a result of this review, the BPU submits proposed further revisions, which are attached hereto.

The BPU also requests a waiver of newspaper publication for the further revisions, as the BPU has already complied with the requirements for the initial filing.
