Dear Secretary Burgess:

The enclosed tariff leaves, issued by New York State Electric & Gas Corporation (“NYSEG”) and Rochester Gas and Electric Corporation (“RG&E”) (together the “Companies”) are transmitted for filing in compliance with the requirements of the New York State Public Service Commission (“Commission”) and Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

The Companies are filing modifications to a filing that was originally submitted to the Commission on September 28, 2015. After additional communication with Staff, it was decided the Company would change the proposed language from “NY Transco Charge, TOTS Charge, and AC Transmission Charge” to “Transmission project costs allocated to the Company under the NYISO tariff as approved by FERC”. The revised language will better accommodate the FERC and Commission review and approval process for transmission projects. 
