New York State Electric & Gas Corporation ("NYSEG") and Rochester Gas and Electric Corporation ("RG&E") (the "Companies") hereby transmit for filing the enclosed tariff leaves in compliance with the New York State Public Service Commission's ("NYPSC" or "Commission") Order Authorizing Utility-Administered Gas Energy Efficiency Portfolios for Implementation Beginning January 1, 2016, issued and effective June 19, 2015 ("the Order") in the above-referenced proceedings. These tariff leaves are transmitted for filing in compliance as identified herein and in accordance with the requirements of Appendix 7-H (electronic tariff filing system) to the Commission's Codes, Rules and Regulations (16 NYCRR Appendix 7-H).

The Companies had filed tariff amendments on July 20, 2015, to implement the Energy Efficiency Tracker on January 1, 2016. After additional communications with Staff, it was decided to include the Energy Efficiency Tracker as a component of the System Benefits Charge instead of as a separate surcharge provided for in the tariffs. A list of the revised tariff leaves to become effective January 1, 2016 is provided as Appendix A.
