Effective: January 1, 2016

In accordance with Ordering Clause No. 3 of the above Order, utilities were directed to file tariffs instituting an electric Energy Efficiency Tracker within 30 days of the issuance of the Order to become effective January 1, 2016. The purpose of this filing is to comply with the Order and revise the Company's tariff to implement an Energy Efficiency Surcharge (EES). Specifically, Rule 40 - Energy Efficiency Surcharge has been added to PSC No. 220 Electricity setting forth the mechanism which would permit the

Company to recover the cost of energy efficiency programs conducted by the Company. The EES will be applicable to all customers who currently are subject to the System Benefits Charge with the same exclusions applying to the EES. Also included with this filing is a pro-forma Statement of System Benefits Charge for PSC No. 220 and PSC 214 to take effect January 1, 2016. Attachment 1 included with this filing sets forth the derivation of the EES rate.

The EES will be set forth on the Statement of System Benefits Charge, filed three days before the effective date, and will be included in the calculation of the total System Benefits Charge included on the customer's bill.

Newspaper publication of these revisions as required in 16 NYCRR 720.8 and PSL §66-1 will be completed on August 6, 13, 20 and 27, 2015.
