Overview

The Company is proposing tariff changes to reflect the changes to RG&E's portfolio of natural gas pipeline transportation and storage assets. The Canadian Delivery, Storage and Re-Delivery Service (DSR) expired March 31, 2015. RG&E has contracted for Empire Pipeline Tuscarora Storage and the associated Empire pipeline transportation. The new storage will be a 60-day service that will be released to Energy Service Companies (ESCOs) beginning November 1, 2015 on a mandatory basis. RG&E proposes a one-time only infield storage transfer to ESCOs on November 1, 2015. The infield storage transfer will include commodity and demand costs associated with holding and filling the storage from April 2015 through October 2015.

The proposed tariff describes the process for assignment of the transportation and storage capacity, and the transfer of storage gas and capacity between the Company and ESCOs.

Publication

The Company respectfully requests the requirement of 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 regarding newspaper publication be waived. The Company directly notified ESCOs of the proposed changes at a Gas Marketers Operating Group meeting held on July 21, 2015, to discuss the proposed tariff changes with ESCOs.

A State Administrative Procedure Act Notice is enclosed for publication in the State Register.
