Purpose of Filing

The Companies are filing tariff amendments in compliance with Ordering Clause No. 1 of the Order to implement distribution-level demand response programs.

Overview

On December 15, 2015, the Commission issued Order Instituting Proceeding Regarding Dynamic Load Management and Direct Tariff Filings, in the above referenced proceedings requiring the Companies to submit draft tariffs for the implementation of distribution-level demand response programs. The leaves were submitted as drafts on March 25, 2015 ("March Filings").

The Companies had proposed three new distribution-level demand response programs; the Distribution Load Relief Program, the Commercial System Relief Program and the Direct Load

Control Program. The Companies also proposed to recover costs associated with these programs through the Transition Charge.

The Order directed the Companies to amend the March filings to designate the areas where the Commercial System Relief Program ("CSRP") and the Distribution Load Relief Program ("DLRP") will be available. The Companies will list the designated areas on each Company's website.

Additionally, the Commission also directed the Companies to redesign their proposed CSRP payments to allow Mandatory Hourly Pricing and Voluntary Hourly Pricing customers to fully participate in both the Reservation and Voluntary options of the CSRP programs in summer 2015.

Publication

Requirements of Public Service Law Section 66 (12) (b) as to newspaper publication of the tariff revisions are waived pursuant to the Ordering Clause No. 7.
