**To: Municipalities and Water Districts Receiving Water from the
Water Supply System of the City of New York**

Pursuant to a court order, the FY 2017 Rate Schedule adopted by the New York City Water Board on May 20, 2016 will not go into effect on July 1, 2016 as previously announced. The rates and charges provided for during FY 2016 will remain in effect until further notice. This includes the rates and charges paid by communities located north of New York City.

The FY 2016 rates were effective as of July 1, 2015, and provided that the rate for water sales **that do not exceed** the allowance quantities of water authorized to each municipal corporation or water district pursuant to §24-360 of the Administrative Code of the City of New York shall be \$1,728.99 per million gallons.

Also as of July 1, 2015, the uniform metered water rate that applies to water sales **that exceed** the allowance quantities of water authorized to each municipal corporation or water district pursuant to §24-360 of the Administrative Code of the City of New York remains at \$5,093.58 per million gallons.
