## RE: Case 19-E-0079, In the Matter of the Continuation of Standby Rate Exemptions, Housekeeping Changes

Dear Secretary Phillips:

Consolidated Edison Company of New York, Inc. ("Con Edison" or the "Company") is filing with the Public Service Commission (the "Commission") amendments to its Schedule for Electricity Service, P.S.C. No. 10 – Electricity (the "Electric Tariff") applicable to its customers in the City of New York and the County of Westchester. The Company is also filing amendments to its Schedule for PASNY Delivery Service, P.S.C. No. 12 – Electricity (the "PASNY Tariff"),<sup>1</sup> applicable to delivery by the Company of power and associated energy to Authority Public Customers under the PASNY Tariff.

The revised Electric Tariff and PASNY Tariff Leaves, which are identified below, are filed to become effective on September 29, 2023.

## **Reason for Filing**

This filing is a further revision to the filing that the Company made on May 31, 2023 that became effective on June 1, 2023, in compliance with the Commission's *Order Continuing and Modifying Standby Rate Exemptions* (the "Exemption Order"), issued May 18, 2023, in the above referenced proceeding.

The Company is making this housekeeping filing to incorporate tariff revisions that the Company filed on September 30, 2022 that became effective on July 1, 2023, as approved by the Commission in its *Order Approving Tariff Modifications*, issued in March 17, 2023 in Case 22-E-0549, with the tariff revisions in the above filing. The Electric and PASNY Tariff leaves being filed today incorporate the language from both filings.

## **Conclusion and Notice**

As directed by Ordering Clause 1 of the Exemption Order, this filing is being made on not less than one days' notice to become effective on a temporary basis on September 29, 2023. The Company respectfully requests a waiver of the requirement for newspaper publication for this filing as the proposed changes are housekeeping in nature.
