Dear Secretary Phillips:

New York State Electric & Gas Corporation (“NYSEG”) and Rochester Gas and Electric Corporation (“RG&E”), (together the “Companies”) hereby file the following tariff leaves in compliance with Ordering Clause No. 1 of the Public Service Commission’s Order Continuing and Modifying Standby Rate Exemptions in the above referenced proceeding, issued and effective May 18, 2023 (the “Order”) and Appendix 7-H (electronic tariff filing system) to the Commission’s Codes, Rules and Regulations (16 NYCRR Appendix 7-H). The tariff leaves are to become effective on a temporary basis June 1, 2023.

Purpose of Filing

The Companies are filing amendments to their respective tariffs in compliance with Ordering Clause No. 1 of the Order.

More specifically, within the Standby service classification, the Companies are removing sunset dates for the Designated Technologies Exemption and updating the list of technologies eligible for the Designated Technologies Exemption. The tariff revisions reflect the addition of fuel cells that do not utilize fossil fuels to the list of technologies eligible for the Designated Technology Exemption, and removed the Designated Technology Exemption for sustainably managed biomass, biogas, and fuel cell units which utilize fossil fuel resources that are installed on or after June 1, 2023. Installations of sustainable managed biomass, biogas, and fuel cell units

which utilize fossil fuel resources that are installed before June 1, 2023 continue to be exempt from Standby rates.
