**RE: Case 19-E-0079 – In the Matter of the Continuation of Standby Rate Exemptions**

Dear Secretary Phillips:

The following tariff amendments, issued by Niagara Mohawk Power Corporation d/b/a National Grid (the Company), are being transmitted in compliance with the November 21, 2022 *Order Directing Tariff Filings* issued by the New York State Public Service Commission (Commission) in the above case number:

Thirteenth Revised Leaf No. 418  
To P.S.C. No. 220 Electricity

Effective: December 1, 2022

On May 14, 2021, the Commission issued the *Order Continuing Certain Exemptions to Standby Rates* ("Standby Exemptions Order"), which directed the Joint Utilities<sup>1</sup> to file a proposal that would harmonize standby service exemptions statewide ("Harmonization Response"). The Joint Utilities submitted the Harmonization Response on July 13, 2021, requesting that the Commission authorize National Grid, Central Hudson, NYSEG, and RG&E to make certain amendments to their respective tariffs to align the standby service exemptions across the Joint Utilities' service territories. National Grid's proposed tariff amendments extended eligibility for the Designated Technologies to all Designated Technologies of any size, with exception of the current exemption for energy storage systems of one MW of inverter capability or less. The Order approved the Company's proposed tariff amendments.

The Company has removed language from Leaf 418 of Service Classification No. 7 – Sale of Standby Service to Customers, which detailed the generator nameplate capacity of the Designated Technologies.

Ordering Clause No. 1 of the Order directed the Company to file tariff amendments on not less than one day's notice, to become effective on December 1, 2022. Ordering Clause No. 3 of the Order waived the requirements of PSL §66 (12) (b) and 16 NYCRR §720-8.1 concerning newspaper publication of tariff amendments.
